### Strengthening and Advancing Equality and Human Rights in Wales Report

This was led by Professor Simon Hoffman and funded by the Welsh Government.

The research (2021) findings outline mechanisms to strengthen and advance equality and human rights in Wales including 40 recommendations for legislative, policy, guidance, or other reforms to meet this objective.


The recommendations, if fully implemented by the Welsh Government, would mean that Ministers are more accountable for how they comply with children's rights.



Crownbridge Special Day School, Cwmbrian, is featured in 'Know your Rights and Claim Them' for their research and advocacy on accessibility in their town centre.


The Lleisiau Bach Little Voices team worked with them supporting their research and its impact with partnerst, including Torfaen Borough Council.

**Research Finds That Covid-19 Emergency Measures Have Had a Negative Impact on Children’s Rights Across Europe**

This was the finding from research carried out by Professor Simon Hoffman and Dr Rhian Croke for the European Network of Ombudsmen for Children (ENOC):

‘Mapping the Impact of Emergency Measures Introduced in Response to the Covid-19 Pandemic on Children’s Rights in ENOC Member States’. Professor Hoffman and Dr Croke presented their findings to the ENOC Annual Conference (September 2021), and were used to inform the ENOC 2021 Position Statement on government response to public emergencies.
